#### Kenya

#### 1. Summary of key findings

#### Household characteristics

- The population structure of the population structure is similar to the country's structure with over 50% of women in population, about 25% below 15 years and 50% in the labor force. The structure does not differ significantly across the household with and without migrants.
- The major difference between the household type is on the level of education. It shows that most of the household members with university level education are among the households with international migrants. The household heads in households with international migrant have higher education than those in the internal and non-migrant households. The other major difference is that households with a international migrant has a head who is professional in his/her current occupation.
- A high proportion of households are owned and family houses with a higher proportion among households with international migrant. Similarly household with an international migrant have a higher proportion of houses constructed using stones and with higher supply of utilities.
- Households with international migrant have a proportionately higher ownership of household durable goods including car, television, computer and refrigerator.
- 63% of households indicate that they own bank account with a proportionate higher number of households among households with international migrant.

#### International and internal migrants characteristics

- Migrants are generally male. Most of the migrants both international and internal are with the 26-50 years old. These are again sons and daughters of the households.
- Most of international migrants are in OECD countries with majority in UK and USA. Those migrating to African countries are in the EAC countries.
- 39% Of international migrants are in search for education while the internal migrants are mostly looking for employment opportunities.

- Over 25% of both internal and international migrants have been away for between 1 to 3 years.
- The migrants moved after they finished their secondary school. International migrants have a higher proportion who had already finished undergraduate therefore in search for higher education.
- Internal migrants have a higher proportion who were unemployed before they left and engaged currently in self-employment. 36% of international migrants are professionals in their current occupation. This confirming the fact that those who migrate to outside countries are getting more educated.
- Migrant send money back home both international and internal, with an average amount kshs 50,000 and below. The method of sending differ by region with those in international corridors using western union while the internal migrants use the mobile telephone services.
